Research & Insights (RM6126) - Assurance documentation

Are you due to renew or have you just renewed? Remember you must have the following documents in place to be an appointed supplier :

Insurances

Professional Indemnity up to £1 million per individual claim
Public Liability up to £1 million per individual claim
Employer's liability with the minimum limit of £5 million as required by law

Carbon Reduction Plan

You must have a carbon reduction plan in place, CCS runs training on completing this on a regular basis.

• Cyber Essentials Accreditation (or ISO 270001 as an alternative)

You are required to obtain the Cyber Essentials basic accreditation. This must be renewed by the anniversary of its issue. We advise that you begin the renewal process
